### **ELIGIBILITY**

- a. Applicants in any of the following categories are entitled to veterans' preference if they have completed their military service commitment and have received an honorable discharge from such service prior to taking a civil service test.
- (1) Certain military commitments completed prior to July 27, 1953.
- (2) Applicants who have served in an active duty capacity in the armed forces of the United States since July 27, 1953. Such service must include completion of basic training.
- (3) Applicants who served in the National Guard or Reserves. Such service must include completion of basic training and completion of either the entire first term of service or at least one period of active duty for a purpose other than training since August 2, 1990.
- b. Also eligible are:
- (1) Widows or widowers of veterans.
- (2) Spouses of disabled veterans.

### **NON-ELIGIBILITY**

- a. Applicants who have not completed their initial military service commitment including National Guard and Reserve members currently in their first term of service, who have not been called to active duty for any purpose other than training. b. Widows or widowers of veterans who remarry.
- c. Divorced spouses of disabled veterans.

# ACCEPTABLE FORMS OF DISCHARGE OR RELEASE FROM ACTIVE DUTY

The applicant's most recent discharge or release from active duty status must have been under honorable conditions which would include but not be limited to: honorable discharge, general discharge, good discharge, satisfactory discharge, indifferent discharge or special order discharge. An applicant awarded a dishonorable discharge, bad conduct discharge, undesirable discharge, a

dismissal or any other type of separation certificate given under conditions other than honorable would NOT be entitled to veterans' preference.

### **VETERANS' PREFERENCE**

Applicants who pass civil service tests required for appointment to positions covered by the State's Merit System receive additional benefits in recognition of their military service. These benefits commonly are referred to as veterans' preference. The authority for veterans' preference in Pennsylvania government employment is contained in The Military Affairs Act of August 1, 1975 (P.L. 233, No. 92), as amended.

### **APPLYING FOR VETERANS' PREFERENCE**

Applicants claiming veterans' preference must submit the following documents with their application:

- a. <u>Veterans.</u> A photocopy of service discharge, DD Form 214\* or other military document(s) showing date of entry, successful completion of basic training, completion of the military service commitment and character of service.
- b. <u>Widows and Widowers</u>. A photocopy of spouse's service discharge DD Form 214\* or other military document(s) showing date of entry, successful completion of basic training, completion of the military service commitment, character of service and a certified copy (not a photocopy) of the death certificate of spouse.
- c. <u>Spouses of Disabled Veterans.</u> A photocopy of spouse's service discharge, DD Form 214\* or other military document(s) showing date of entry, successful completion of basic training, completion of the military service

commitment, character of service, a
Department of Veterans Affairs letter
dated within the past six months
verifying that the veteran is receiving
compensation for a service connected
disability and a signed statement from
the disabled veteran showing social
security number and agreeing to transfer
credit to spouse.

These documents need to be submitted to establish your claim and create your record. Originals should NOT be submitted as documents cannot be returned. You may be required to present originals if copies are unreadable or if needed to prove authenticity.

## TRANSFER OF VETERANS' PREFERENCE

A disabled veteran may assign his or her preference to a spouse by submitting the documentation listed in C under "APPLYING FOR VETERANS' PREFERENCE". The preference may be recovered by the disabled veteran if the spouse is not on a current civil service list with veterans' preference or is not currently employed in a civil service position achieved as a result of veterans' preference.

### APPLYING VETERANS' PREFERENCE TO CIV-IL SERVICE TESTS

- a. Veterans, qualified widows and widowers of veterans and spouses of disabled veterans who pass civil service appointment tests, receive ten points added to their final score. They must pass the test before points are awarded.
- b. Applicants who take a civil service test **BEFORE** being honorably discharged from

their military service commitment will never be entitled to receive an additional ten points added to that test score. However, upon completing their commitment and being honorably discharged, they will immediately become eligible for preference as a veteran. If such applicants thereafter retest or take other tests successfully, they will receive both the ten additional points and preference.

- c. Applicants entitled to veterans' preference who are among the top three available candidates on certifications have mandatory preference in appointment over non-veterans.
- d. Applicants entitled to veterans' preference on a civil service list may be appointed regardless of their rank on the list.

# VETERANS' PREFERENCE IS NOT APPLICABLE FOR PROMOTIONS

Veterans' preference does NOT apply to promotions. However, current civil service employees holding less than full-time or permanent employment in intermittent, seasonal, part-time, emergency and temporary positions continue to receive veterans' preference. In addition, applicants appointed to emergency, temporary, provisional or qualifier status will also continue to receive veterans' preference.

# VETERANS' PREFERENCE FOR FURLOUGH PURPOSES

Certain periods of military service are counted in computing seniority used for furlough purposes if a reduction in the workforce becomes necessary.
